KEY OUTCOMES OF COP29



Climate Finance

Commitment to triple annual funding for developing countries to \$300 billion by 2035.

Secure efforts of all actors to mobilize \$1.3 trillion annually from public and private sources.



Carbon Markets

Finalised carbon market agreement by adopting the operationalization rules and guidelines for Article 6 of the Paris Agreement.



Adaptation

Launch of the Baku Adaptation Road Map.

Support program for National Adaptation Plans (NAPs) initiated.

AT COP29, RWANDA STRENGTHENED ITS CONTRIBUTION TO CLIMATE NEGOTIATIONS AND MOBILISED NEW RESOURCES AND PARTNERSHIPS FOR GREEN INVESTMENT.





Transparency

Baku Global Climate Transparency Platform (BTP) was launched.

Biennial Transparency Reports progress marked, with 13 parties submitting their BTRs.

Loss and Damage

Rules for the advisory board of the Loss and Damage fund established.

New pledges raised the total fund to \$731.15m.

COP29 AND RWANDA'S NDCs 3.0

How will COP29 inform the development of Rwanda's new climate action plan?



OUTCOMES INTEGRATION

Leverage increased climate finance to scale mitigation and adaptation projects.

Apply carbon market operational guidelines to expand trading mechanisms.



STRATEGIC ALIGNMENT

Align COP29 outcomes with **Rwanda's Climate and Nature** Finance Strategy.

Build on national efforts for transparency under the Enhanced **Transparency Framework.**



WHOLE OF GOV APPROACH

Build on the cross-government participation at COP29 to build support for Rwanda's NDCs 3.0.

Encourage participation in the NDCs 3.0 Consultation Process.
